The signature event of the American Society of Safety Professionals (ASSP) continues to grow in popularity. Final numbers from ASSP's Safety 2018 Professional Development Conference & Exposition show that 8,641 people took part in the June event, surpassing the organization's previous record crowd in Denver last year.
